If you feel unwell, have a contagious illness, such as a cold, please advise your host. This may restrict access into a manufacturing area.



Information that you are provided with or are privy to during your visit is strictly confidential unless permission has been granted for you to use this information elsewhere. Do not take photographs or video footage unless your host has given you permission to do so.



It is prohibited to smoke or vape anywhere on site. Please speak to your host for guidance.



We are a drug and alcohol free site.



Please make sure that your visitors badge is visible at all times.



Please advise your host if you are pregnant as there may be restrictions on the areas that you can visit.



We host visitors and customers from diverse backgrounds and have a quiet/prayer room available. If you would like to use this facility, please speak with your host.



Stay with your host at all times.



The site speed limit is 5mph. Please reverse park into the marked spaces.

Health and safety

Health and Safety is our number one priority. Your safety whilst on our site is important to us so please make sure you follow the key rules and procedures.



Do not enter any manufacturing area or prohibited area without getting permission first.



Report any accidents or incidents to your host immediately. We have trained first aiders and also mental first aiders on site to help you.



Near misses are those opportunities to prevent an accident from happening; if you see something you believe could cause harm, injury or damage please report this to your host.



Ensure that any PPE (personal protective equipment) provided is worn correctly at all times necessary.



Be aware that forklifts operate around site.



Wear high-viz clothing and use the pedestrian walkways and crossings when walking around site.



Hold the hand rail while using the stairs.




Do not use your mobile while walking.

Fire alarm and emergency evacuation

Ask your host to explain the evacuation process to you.

Fire alarms are tested early every Thursday morning. Any fire alarms that you hear, unless otherwise advised, should be treated as real. Your host will ensure that you take the appropriate action.

If you are separated from your host and you hear a continuous bell, please leave the building by the nearest exit and head to main reception. If reception is in continuous alarm, go to assembly point 3A.
